**ANIMAL SERVICES MONTHLY REPORT FOR
JULY 2014**

Program Highlights

- Volunteers donated approximately 1273.25 hours in July in the areas of animal care, PEET canvassing, socialization, administration needs, TNR program, and several special events including vaccine clinics in Bakersfield.
- July was a busy month once again for media contact, inquiries and interviews for the Department. The Marketing & Promotions Associate responded to 51 media inquiries and requests providing information to the media on various topics such as field services including arrests and wildlife calls; 4th of July pet safety tips; vaccination clinics; spay/neuter resources; operations, and adoption promotions. Of those 51 contacts, 20 resulted in interviews or postings for newspaper, television and radio media outlets via video, newsprint on the news agency websites and papers and on Facebook pages.
- The Rescue Team made one trip to Mt. Shasta where 40 dogs were transported after the KCAS medical team heartworm tested and health inspected each pet to ensure that they could cross over into Washington State. An additional 135 animals from KCAS shelters were pulled by rescue agencies for a grand total of 175 animals that were saved by rescue organizations in July.
- Our Foster Program continues to grow and save more lives. 40 new animals entered the foster care program during the month of July. On average, the foster team receives at least 3 applications per week for new foster homes.
- Starting July 1, 2013, the Department implemented its first ever Trap-Neuter-Return (TNR) program for feral and free-roaming cats, joining thousands of other agencies across the country embracing TNR as the humane method to control the feral and free-roaming cat populations. The program has been extremely successful with 230 cats being spayed or neutered and returned to the areas where they were trapped in July. The total number of cats that have been altered since the beginning of the program is 1625.
- The Department hosted a successful, low-cost vaccination, licensing and microchip clinic held in Taft (Ford City Park). 155 licenses, 121 Rabies vaccinations, 82 DHPP vaccinations, 3 FVRCP vaccinations, and 90 free microchips were implanted during this vaccination clinic.
- The Department's new Wednesday evening vaccination, licensing and microchipping clinics at the new Fruitvale Shelter location in Bakersfield continued in June with 103 DHPP vaccinations, 23 FVRCP vaccinations, 133 Rabies vaccinations, 142 licenses and 98 microchips were issued during the four Wednesday evening clinics. The Department plans to continue to offer the Wednesday evening clinics on an on-going basis to assist pet owners in keeping their pets healthy and happy.
- We continue to provide free microchips for all pet owners both onsite at all three shelters and at our low-cost clinic locations. We have implanted a total of 6,803 microchips for County and City residents since the program began on October 23, 2012.
- The Department's medical team was extremely busy this month performing 61 spays and 106 neuters on site for a total of 167 surgeries performed.

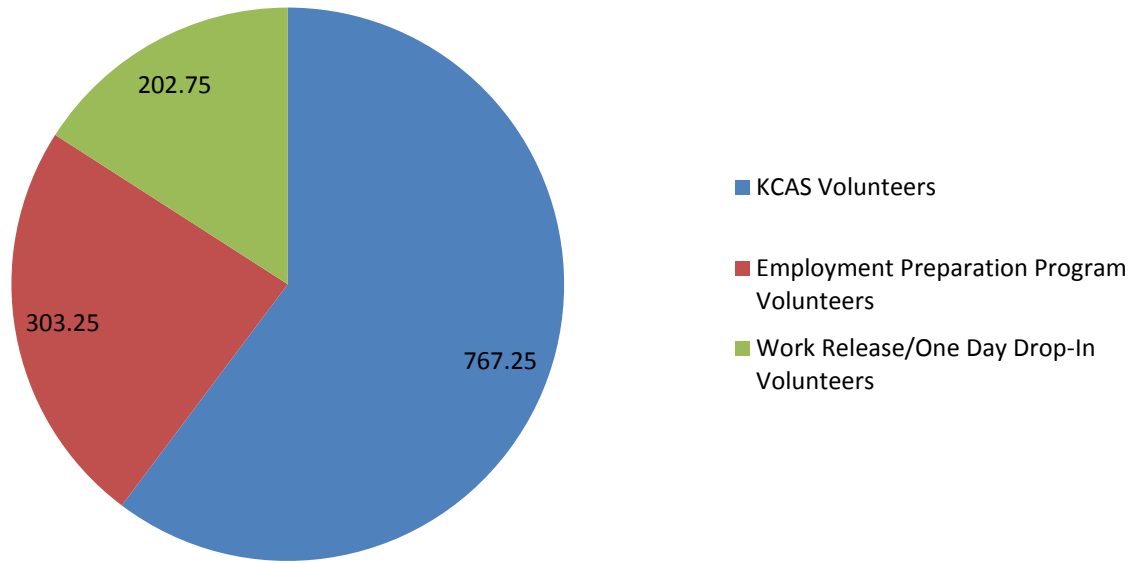
