**ANIMAL SERVICES MONTHLY REPORT FOR
JUNE 2015**

Program Highlights

- Volunteers donated approximately 1411.75 hours in June in the areas of animal care (including puppies, cats, general kennels and horses), administration needs, grooming, cleaning, socialization, dishes and linens, and several special events. There were 98 active volunteers in June. Of the 141,175 original hours, 945.50 hours were completed by regular KCAS volunteers, 28.25 hours were completed by employment preparation volunteers, 405 hours were completed by work release volunteers and 33 hours were completed by one day volunteers. Total volunteer time equates to 5.4 staff members and the value given back to KCAS by current and new volunteers in all areas is \$34,940.81.
- June was a busy month once again for media contact, inquiries and interviews for the Department. The Marketing & Promotions Associate responded to 25 media inquiries and requests providing information to the media on various topics such as field services including wildlife calls; vaccination clinics; spay/neuter resources, Wings of Rescue flights; collaboration with community agencies, the Department's annual participation in the Just One Day event, partnership with a local Eagle Scout candidate for a shade structure at the Bakersfield shelter location, and fireworks safety tips for pets, including a joint press conference with the Kern County Fire Department and a live morning show appearance on KGET 17 news. Of those 25 contacts, 19 resulted in interviews or postings for newspaper, television and radio media outlets via video, newsprint on the news agency websites and papers and, on Facebook pages.
- The Rescue Team focused their life-saving efforts on coordinating placement with individual rescues as the rescue transport vehicle was in the garage for repairs. Thanks to the many wonderful rescue partners that KCAS works with on a regular basis, 137 animals were rescued in June.
- Our Foster Program continues to grow and save more lives. 112 new animals entered the foster care program during the month of June.
- Starting July 1, 2013, the Department implemented its first ever Trap-Neuter-Return (TNR) program for feral and free-roaming cats, joining thousands of other agencies across the country embracing TNR as the humane method to control the feral and free-roaming cat populations. The program has been extremely successful with 97 cats being spayed or neutered and returned to the areas where they were trapped in June. The total number of cats that have been altered since the beginning of the program is 3,223.
- In honor of National Adopt-A-Cat month, the Department participated in its 7th annual Adopt-A-Cat month adoption promotion where all cat adoption fees were reduced to just \$10 through the month of June. The event was well supported by the public with a total of 153 cats adopted during the month long event, which was an increase of 15% over the same time period as the previous year.

- The Department joined thousands of shelters and rescues across the country on June 11th, pledging to not euthanize any animals during the national “Just One Day” event. This is the fourth year in a row that the Department has participated in the national event. In addition, the Department promoted the importance of adopting pets from a shelter by hosting a special adoption promotion where adoption fees were reduced to just \$11 at all three shelter locations (Bakersfield, Lake Isabella and Mojave). The Bakersfield shelter location had extended adoption hours on this day (9 am to 8 pm) and the public was encouraged to make a difference on the 11th, for 11 hours and with \$11 to save a life. The event was a huge success with 87 adoptions taking place. All of the adoptable pets within the Bakersfield shelter were adopted out during this great event.
- In June, the Department partnered with 4th District Kern County Supervisor David Couch to bring spay and neuter services to unincorporated residents in the Frazier Park and Taft areas. The first clinic was sponsored by Supervisor Couch, KCAS, Mountain Communities Animal Resource Center and Valley Vet Non-Profit to provide spay and neuter services to residents in the Frazier Park area. 30 animals were spayed or neutered at this clinic. A voucher distribution day was sponsored by Supervisor Couch, KCAS, Kern County Library and Dr. Ross with Taft Veterinary Hospital to provide spay and neuter services for residents in the Taft area. 140 vouchers were issued to cat owners over a two-day period in Taft. The vouchers are set to be used in 30 days from the date of issuance at Taft Veterinary Hospital. The Department will continue partnering with additional agencies and the Kern County Board of Supervisors to bring spay/neuter services to as many unincorporated residents as possible.
- KCAS hosted two successful, low-cost vaccination, licensing and microchip clinics in Bakersfield (Greenacres Park) and McFarland (Browning Road Park). 115 licenses, 100 Rabies vaccinations, 215 DHPP vaccinations, 5 FVRCP vaccinations, and 65 free microchips were implanted during these vaccination clinics.
- A generous donation was made to the Department by the students and staff of the Milan Institute. A check was presented to the Department for \$462 as a result of total revenue raised from all services performed at the Milan Institute student salon and massage spa located in Bakersfield. The fundraiser was a success thanks to the hard work and dedication of the students, faculty and staff. Clients were happy to know that the cost of their haircut, highlights, pedicure, massage and other services that day would help support a worthy cause. We are planning for future partnerships with the Milan Institute.
- KCAS partnered with a local Eagle Scout candidate to bring shade to the exercise yard at the Bakersfield shelter location. Jeff Aceves, from Troop 47, began work on the construction of the play yard earlier in the month with 12 other scouts from his troop. The group prepared the site for the structure by digging holes and cementing the structural poles. About two weeks later the group returned to erect the shade structure. The structure is complete and now provides a large area of shade in the exercise yard so that staff, volunteers and the animals can enjoy outside time every day.
- The Department’s new Wednesday evening vaccination, licensing and microchipping clinics at the Fruitvale Shelter location in Bakersfield continued in June with 198 DHPP vaccinations, 24 FVRCP vaccinations, 164 Rabies vaccinations, 155 licenses and 98 microchips issued during the four Wednesday evening clinics.
- We continue to provide free microchips for all pet owners both onsite at all three shelters and at our low-cost clinic locations. We have implanted a total of 9,318 microchips for Kern County residents since the program began on October 23, 2012.

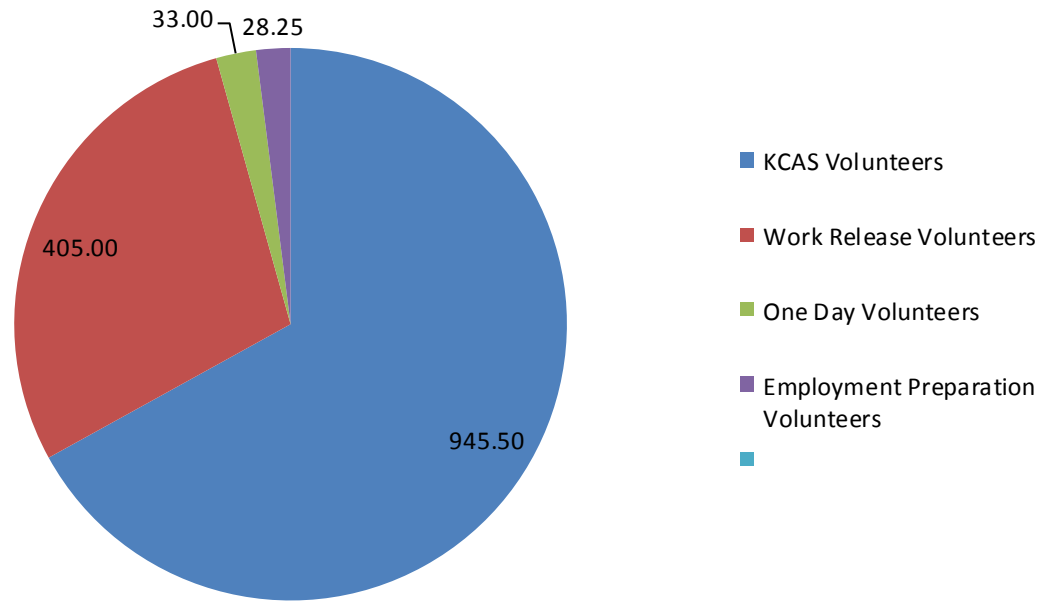

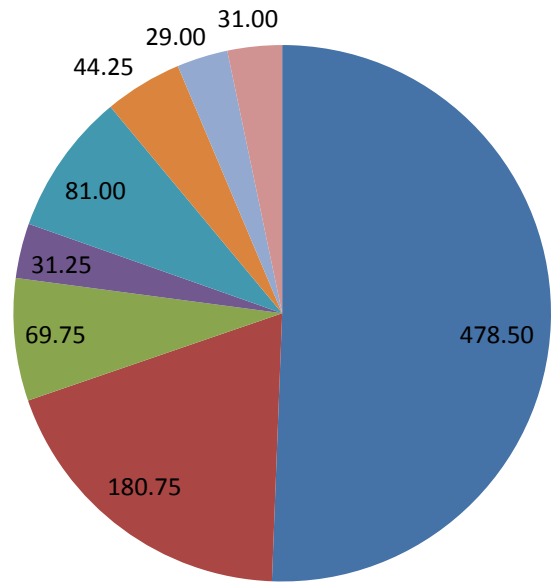
