**ANIMAL SERVICES MONTHLY REPORT FOR
JULY 2015**

Program Highlights

- Volunteers donated approximately 1860 hours in July in the areas of animal care (including puppies, cats, general kennels and horses), administration needs; grooming; cleaning; socialization; dishes; linens, and several special events. There were 105 active volunteers in July. Of the 1860 original hours, 1007.50 hours were completed by regular KCAS volunteers, 190 hours were completed by employment preparation volunteers, 658.25 hours were completed by work release volunteers and 4.25 hours were completed by one day volunteers. Total volunteer time equates to 10.7 staff members and the value given back to KCAS by current and new volunteers in all areas is \$46,035.00.
- July was a busy month once again for media contact, inquiries and interviews for the Department. The Marketing & Promotions Associate responded to 21 media inquiries and requests providing information to the media on various topics such as field services including wildlife calls; vaccination clinics; spay/neuter resources; collaboration with community agencies during the East Bakersfield Collaboration Open House; foster and volunteer needs; fireworks safety tips for pets, including a live morning show appearance on KGET 17 news and, information on National Mutt Day on the KBAK 29 live morning show. Of those 25 contacts, 15 resulted in interviews or postings for newspaper, television and radio media outlets via video, newsprint on the news agency websites and papers and, on Facebook pages.
- The Rescue Team coordinated a transport to Port Richmond where 39 animals (cats and dogs) were able to find new loving homes. Rescue partners saved an additional 181 animals, for a grand total of 220 animals saved in July.
- Our Foster Program continues to grow and save more lives. 67 new animals entered the foster care program during the month of July.
- Starting July 1, 2013, the Department implemented its first ever Trap-Neuter-Return (TNR) program for feral and free-roaming cats, joining thousands of other agencies across the country embracing TNR as the humane method to control the feral and free-roaming cat populations. The program has been extremely successful with 121 cats being spayed or neutered and returned to the areas where they were trapped in July. The total number of cats that have been altered since the beginning of the program is 3,344.
- The Department hosted a special end of the month promotion at the end of July to encourage the adoption of animals in the shelter entitled, "All You Need is Love." The promotion reduced the dog adoption fees to just \$20 and cat adoption fees to just \$5. The promotion was extremely successful and well received by the public as 102 cats and 104 dogs as well as 2 horses, 1 goat and 1 lizard were adopted in the 11 day time period. The total number of animals adopted in July was 440.

- KCAS hosted one successful low-cost vaccination, licensing and microchip clinic in Taft (Ford City Park). 198 licenses; 164 Rabies vaccinations; 86 DHPP vaccinations; 12 FVRCP vaccinations and, 91 free microchips were implanted during this vaccination clinic.
- Special donations were given to the Department by 9-year old Silver Winders and The California Distinguished Women's group during the month of July. Instead of asking for birthday presents, Silver asked her friends and family to help her collect donations for the shelter pets. Silver and her mom went to Petco and using the cash she received in lieu of presents, purchased toys, treats and food for the shelter animals. The California Distinguished Women's Group visited the shelter for the second year in a row to drop off their donation of homemade blankets for the animals. Each year the participants are encouraged to pick a project to support through community service and for the second year in a row, the group has chosen to support KCAS.
- The Department's new Wednesday evening vaccination, licensing and microchipping clinics at the Fruitvale Shelter location in Bakersfield continued in July with 199 DHPP vaccinations; 40 FVRCP vaccinations; 172 Rabies vaccinations; 162 licenses and, 117 microchips issued during the five Wednesday evening clinics.
- KCAS, as part of the Kern County East Bakersfield Allied Agency Collaborative celebrated an open house for the Kern County Sheriff Substation earlier in July. The Department hosted an information booth and had spay/neuter vouchers on hand for qualifying residents. Sammy the mascot also made an appearance at the event to encourage pet owners to become responsible pet owners.
- We continue to provide free microchips for all pet owners both onsite at all three shelters and at our low-cost clinic locations. We have implanted a total of 9,584 microchips for Kern County residents since the program began on October 23, 2012.

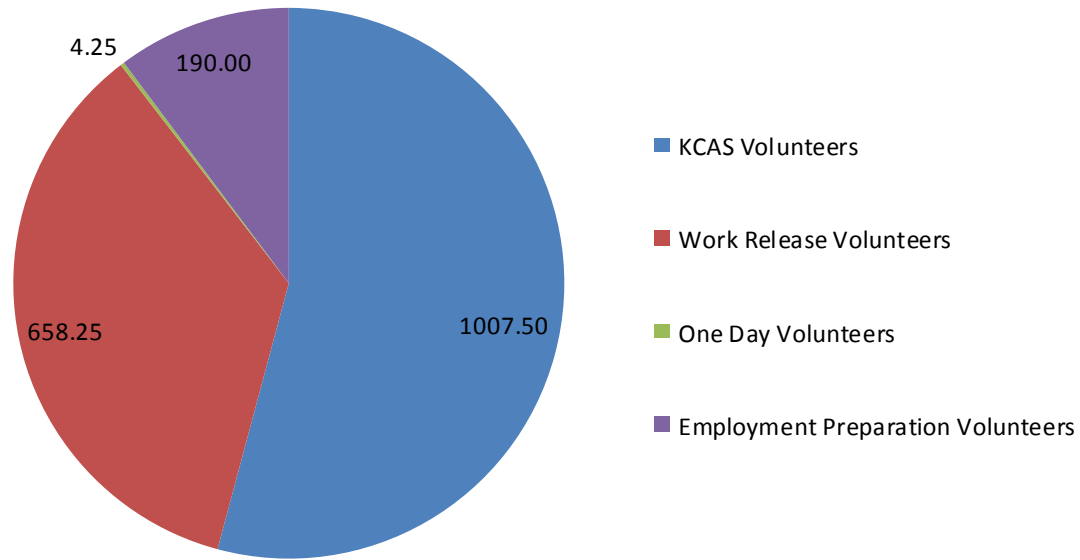
