ANIMAL CONTROL DIVISION MONTHLY REPORT FOR April 2012

Program Highlights

- Volunteers donated approximately 424.15 hours in April in the areas of shelter office support, adoption center assistance, grooming, cleaning assistance and off-site adoption events. Two off-site adoption events were held at PETCO and at Public Health's Health and Wellness Festival for a total of 68.5 hours of the original 424.15 volunteer hours. Volunteers assisted in finding homes for 29 animals this month.
- The Happy Kern Cats PetSmart Charities® Grant to fund free spaying/neutering of feral and free-roaming cats in the 93306 area continued with two more successful clinics in April. The total number of cats spayed or neutered since the program began in November 2011 is now 721. Three more dates are scheduled for May.
- Staff made 3 trips to both Northern and Southern California to transport dogs and cats to rescues in those areas. Approximately 130 animals received new homes due to the transports by staff.
- Kern County Animal Control staff participated in three successful off-site adoption events during April. An Animal Control Officer participated in the American Lung Association's Fight for Air Walk at Yokut's Park, where 6 dogs were adopted to some wonderful families. The Marketing & Promotions Associate, the Animal Care Program Specialist, a member of the Rescue Team and Sammy the St. Bernard attended the 17th Annual Kern County Scottish Society's Annual Games & Gathering at the Kern County Museum, where 1 dog was adopted and nearly 100 hundred people dropped by the booth to visit with the animals, take pictures with Sammy and learn about responsible pet ownership. The final event attended was Public Health's Health and Wellness Festival at Central Park at Mill Creek. 24 dogs and 5 cats were adopted out during this event with the assistance of 12 volunteers and most of the shelter staff. The team provided information on responsible pet ownership, services provided by animal control, spay/neuter options available in the community and the importance of licensing and vaccinating pets.
- An Animal Control Officer attended the Buttonwillow Community Fair hosted by the Buttonwillow Community Resource Center. Information was presented to interested community members about responsible pet ownership, importance of spaying/neutering pets, where to find services for spaying/neutering, animal control services in general and vaccination and licensing clinics.

- Kern County Animal Control teamed up with Ronald Reagan Elementary School to host a newspaper drive during the month of April. Due to the teamwork between the school, the Ronald Reagan Parent Club and KCAC staff, parents were able to drop off their children and their newspapers at the same time during a Friday event. The event was extremely successful in gathering hundreds of newspaper donations for the shelter and it also provided a teaching moment for students regarding the importance of recycling and providing care and comfort to shelter animals.
- After an intense two week campaign to be one of 50 shelters nationwide to compete for a \$100,000, it was announced that Kern County Animal Control was a finalist in the ASPCA Rachael Ray \$100K Challenge. The Department placed 6th nationwide during the voting phase and 2nd in the West Division, finishing up the voting with 18,924 votes from supporters. The competition officially begins on August 1st and staff is working on a variety of ideas to implement that will save more lives and hopefully capture the \$100,000 grant prize.
- Staff partnered with several organizations including Valley Vet Non-Profit, Bark Avenue Foundation and the Dog Rescuers to host a free spay/neuter day for cats in Bakersfield. The event was extremely successful and resulted in 59 cats being altered. Due to the overwhelming community support, the clinic was booked within 3 hours of the announcement of the event and, staff is working with the other agencies in the hopes of booking future cat and dog clinics for the public.
- Two successful low-cost vaccination and licensing clinics were held in Rosamond and Bakersfield. 401 licenses, 445 Rabies vaccinations and 250 DHPP vaccinations were administered at these clinics.
