ANIMAL CONTROL DIVISION MONTHLY REPORT FOR
AUGUST 2012

Program Highlights

- Volunteers donated approximately 555.75 hours in August in the areas of shelter office support, adoption center assistance, medical assistance, and cleaning assistance. There were no off-site events held at PETCO this month as the off-site adoption events have been suspended until after the ASPCA/Rachael Ray 100KChallenge competition.
- The Happy Kern Cats PetSmart Charities® Grant to fund free spaying/neutering of feral and free-roaming cats in the targeted 93306 area continued with two more successful clinics in August. Due to the continued dedication and devotion of our volunteer and community partners, 1359 cats were altered, which successfully completes our first year of the program. The additional 59 cats now count toward completion of the second year of the grant which also requires 1300 cats be spayed and neutered. Two more dates are scheduled for September.
- The Department kicked off their participation in the ASPCA/Rachael Ray 100KChallenge in a big way with their first ever no-fee adoption event – Dog Days of Summer...and Cats Too! Over 300 people were estimated to have attended the event and 133 animals found new loving homes that day including a rabbit and a horse. At the end of August, over 500 animals had found new homes with loving families. More events are planned for September and October to help the Department compete for the top grant prizes.
- The Marketing & Promotions Associate was a guest on KERN Radio Newstalk 1180 several times during the month to speak about the ASPCA/Rachel Ray 100KChallenge and Heat Safety Tips for Pets.
- Animal Control adoption staff participated in the Bakersfield Police Department's National Night Out. This event brings citizens and law enforcement agencies together to build a stronger and safer community. Staff showcased the new rescue vehicle and had dogs available for adoption during the event. An information booth provided important information on Department services, responsible pet ownership and how to make a difference in the lives of animals in our community. Two dogs were adopted during this event.

- An Animal Control Officer and a shelter pet presented educational information at an afterschool program through the TAPPS program. 40 students ranging in age from elementary to high school received information on responsible pet ownership, animal control services in general and the importance of taking care of the animals entrusted to our care.
- One low-cost vaccination and licensing clinic was held in Bakersfield. 150 licenses, 324 Rabies vaccinations and 237 DHPP vaccinations were administered at these clinics.
